Space Information Laboratories (SIL), LLC maintains an AS9100D Quality Management System and primarily a Department of Defense prime contractor, a launch vehicle and small satellite flight unit avionics and Li-Ion Battery product supplier to other DOD prime contractors (Lockheed Martin, Boeing, Aerojet Rocketdyne Coleman Aerospace, Northrop Grumman, etc.) and commercial customers. SIL is driven by product innovation and design excellence, delivery flight unit products following our AS9100D process and procedures to ensure delivery of quality flight units that meet our customer requirements.

1. QUALITY MANAGEMENT SYSTEM REQUIREMENTS

Seller shall operate its business in accordance with AS9100 or ISO 9001 Quality Management Systems Requirement for Aviation, Space & Defense Organization. Alternatively, Seller may meet tailored QMS requirements that are appropriate and specific to the Goods or Services offered provided SIL has approved objective evidence of compliance in advance of the purchase order being issued. SIL purchase order will identify supplier quality notes.

2. SERVICES & DELIVERABLES

Seller agrees to provide to SIL (or its subsidiaries, if such subsidiaries are designated as the contracting parties in the purchase order) the services ("Services") and/or goods ("Goods"), described in any purchase order, in accordance with these Terms and Conditions ("Terms & Conditions"). Upon acceptance of a purchase order, shipment of Goods or commencement of a Service, Seller shall be bound by the provisions of this Terms & Conditions, including all provisions set forth on the face of any applicable purchase order, whether Seller acknowledges or otherwise signs these Terms & Conditions or the purchase order, unless Seller objects to such terms in writing prior to shipping Goods or commencing Services. This writing does not constitute a firm offer, and may be revoked at any time prior to acceptance. These Terms & Conditions may not be added to, modified, superseded, or otherwise altered, except by writing signed by an authorized SIL representative. Any terms or Conditions contained in any acknowledgment, invoice, or other communication of Seller, which are inconsistent with the terms and Conditions herein, are hereby rejected. To the extent that this Terms & Conditions might be treated as an acceptance of Seller's prior offer, such acceptance is expressly made on condition of assent by Seller to the terms hereof and shipment of the Goods or beginning performance of any Services by Seller shall constitute such assent. SIL hereby reserves the right to reschedule any delivery or cancel any purchase order issued at any time prior to shipment of the Goods or prior to commencement of any Services. SIL shall not be subject to any charges or other fees as a result of such cancellation.

2.1. DELIVERY

Time is of the essence. Delivery of Goods and Services shall be made pursuant to the schedule, via the carrier, and to the place specified on the face of the applicable purchase order. SIL reserves the right to return, shipping charges collect, all Goods received in advance of the delivery schedule. If no delivery schedule is specified, the order shall be filled promptly and delivery will be made by the most expeditious form of land transportation. If no method of shipment is specified in the purchase order, Seller shall use the least expensive carrier. In the event Seller fails to deliver the Goods or Services within the time specified, SIL may, at its option, decline to accept performance and terminate the Terms & Conditions or may demand its allocable fair share of seller's available Goods and terminate the balance of the Terms & Conditions. Seller shall package all items in suitable containers to permit safe transportation and handling. Each delivered container must be labeled and marked to identify contents without opening and all boxes and packages must contain packing sheets listing contents. SIL purchase order number must appear on all shipping containers, packing sheets, delivery tickets, and bills of lading.

3. IDENTIFICATION, RISK OF LOSS, & DESTRUCTION OF GOODS

Seller assumes all risk of loss until receipt by SIL. Title to Goods shall pass to SIL upon receipt by it of the Goods at the designated destination. If the Goods ordered are destroyed prior to title passing to SIL; SIL may at its option cancel the Terms & Conditions or require delivery of substitute Goods of equal quantity and quality. Such delivery will be made as soon as commercially practicable. If loss of Goods is partial, SIL shall have the right to require delivery of the Goods not destroyed.

4. PAYMENT

As full consideration for the performance of the Services, delivery of the Goods and the assignment of rights to SIL as provided herein, SIL shall pay Seller (i) the amount agreed upon and specified in the applicable purchase order, or (ii) Seller's quoted price on date of shipment (for Goods), or the date Services were started (for Services), whichever is lower. Applicable taxes and other charges such as shipping costs, duties, customs, tariffs, imposts, and government imposed surcharges shall be stated separately on Seller's invoice. Payment is made when SIL check is mailed. Payment shall not constitute acceptance. All personal property taxes assessable upon the Goods prior to receipt by SIL of Goods conforming to the purchase order shall be borne by Seller. Seller shall invoice SIL for all Goods delivered and all Services actually performed. Each invoice submitted by Seller must be provided to SIL within thirty (30) days of completion of the Services or delivery of Goods and must reference the applicable purchase order, and SIL reserves the right to return all incorrect invoices. Unless otherwise specified on the face of a purchase order, SIL shall pay the invoiced amount within thirty (30) days after receipt of a correct invoice. Seller will receive no royalty or other remuneration on the production or distribution of any products developed by SIL or Seller in connection with or based on the Goods or Services provided.

5. WARRANTY

5.1. Goods

Seller warrants that all Goods provided will be new and will not be used or refurbished. Seller warrants that all Goods delivered shall be free from defects in materials and workmanship and shall conform to all applicable specifications for a period of twelve (12) months from the date of delivery to our customers or for the period provided in Seller's standard warranty covering the Goods, whichever is longer. Seller hereby agrees that it will make spare parts available to SIL for a period of five (5) years from the date of shipment at Sellers then current price, less applicable discounts. Additionally, Goods purchased shall be subject to all written and oral express warranties made by Seller's agents, and to all warranties provided for by the **California Commercial Code**. All warranties shall be construed as Conditions as well as warranties and shall not be exclusive. Seller shall furnish to SIL Seller's standard warranty and service guaranty applicable to the Goods. All warranties and Service guaranties shall extend both to SIL and to its customers. If SIL identifies a warranty problem with the Goods during the warranty period, SIL will promptly notify Seller of such problems and will return the Goods to Seller, at Seller's expense. Within five (5) business days of receipt of the returned Goods, Seller shall, at SIL option, either repair or replace such Goods, or credit SIL account for the same. Replacement and repaired Goods shall be warranted for the remainder of the warranty period or six (6) months, whichever is longer.

5.2. Services

Seller represents and warrants that all Services shall be completed in a professional, workmanlike manner, with the degree of skill and care that is required by current, good, and sound professional procedures. Further, Seller represents and warrants that the Services shall be completed in accordance with applicable specifications and shall be correct and appropriate for the purposes contemplated in this Terms & Conditions. Seller represents and warrants that the performance of Services under this Terms & Conditions will not conflict with, or be prohibited in any way by, any other Terms & Conditions or statutory restriction to which Seller is bound.

6. INSPECTION

SIL shall have a reasonable time after receipt of Goods or Service deliverables and before payment to inspect them for conformity hereto, and performance hereunder shall not be deemed accepted until SIL has run an adequate test to determine whether the Goods and Services conform to the specifications hereof. Use of a portion of the Goods for the purpose of testing shall not constitute an acceptance of the Goods. If performance tendered does not wholly conform to the provisions hereof, SIL shall have the right to reject such performance. Nonconforming Goods will be returned to Seller freight collect and risk of loss will pass to Seller upon SIL delivery to the common carrier.

7. INDEPENDENT CONTRACTOR

SIL is interested only in the results obtained under this Terms & Conditions; the manner and means of achieving the results are subject to Seller's sole control. Seller is an independent contractor for all purposes, without express or implied authority to bind SIL by contract or otherwise. Neither Seller nor its employees, agents or subcontractors ("Seller's Assistants") are agents or employees of SIL, and therefore are not entitled to any employee benefits of SIL, including but not limited to, any type of insurance. Seller shall be responsible for all costs and expenses incident to performing its obligations under this Terms & Conditions and shall provide Seller's own supplies and equipment.

8. SELLER RESPONSIBLE FOR TAXES AND RECORDS

Seller shall be solely responsible for filing the appropriate federal, state and local tax forms, including, without limitation, a Schedule C or a Form 1020, and paying all such taxes or fees, including estimated taxes and employment taxes, due with respect to Seller's receipt of payment under this Terms & Conditions. Seller further agrees to provide SIL with reasonable assistance in the event of a government audit. SIL shall have no responsibility to pay or withhold from any payment to Seller under this Terms & Conditions, any federal, state, or local taxes or fees. If required, SIL will report amounts paid to Seller by filing Form 1099-MISC with the Internal Revenue Service.

9. INSURANCE

Seller shall be solely responsible for maintaining and requiring Seller's Assistants to maintain such adequate health, auto, workers' compensation, unemployment compensation, disability, liability, and other insurance, as is required by law or as is the common practice in Seller's and Seller's Assistants' trades or businesses, whichever affords greater coverage. Upon request, Seller shall provide SIL with certificates of insurance or evidence of coverage before commencing performance under this Terms & Conditions. Seller shall provide adequate coverage for any SIL property under the care, custody or, control of Seller or Seller's Assistants.

10. INDEMNITY

Seller shall indemnify, hold harmless, and at SIL's request, defend SIL, its officers, directors, customers, agents and employees, against all claims, liabilities, damages, losses, and expenses, including attorneys' fees and cost of suit arising out of or in any way connected with the Goods or Services provided under this Terms & Conditions, including, without limitation, (i) any claim based on the death or bodily injury to any person, destruction or damage to property, or contamination of the environment and any associated clean-up costs, (ii) Seller failing to satisfy the Internal Revenue Service's guidelines for an independent contractor, (iii) any claim based on the negligence, omissions, or willful misconduct of Seller or any Seller's Assistants, and (iv) any claim by a third party against SIL alleging that the Goods or Services, the results of such Services, or any other products or processes provided under these Terms & Conditions, infringe a patent, copyright, trademark, trade secret, or other proprietary right of a third party, whether such are provided alone or in combination with other products, software, or processes. Seller shall not settle any such suit or claim without SIL's prior written approval. Seller agrees to pay or reimburse all costs that may be incurred by SIL in enforcing this indemnity, including attorneys' fees. Should SIL use, or use by its distributors, subcontractors, or customers, of any Goods or Services purchased from Seller be enjoined, be threatened by injunction, or be the subject of any legal proceeding, Seller shall, at its sole cost and expense, either (a) substitute fully equivalent non-infringing Goods or Services; (b) modify the Goods or Services so that they no longer infringe but remain fully equivalent in functionality; (c) obtain for SIL, its distributors, subcontractors, or customers the right to continue using

the Goods or Services; or (d) if none of the foregoing is possible, refund all amounts paid for the infringing Goods or Services.

11. CONFIDENTIALITY

Seller will acquire knowledge of SIL Confidential Information (as defined below) in connection with its performance hereunder and agrees to keep such SIL Confidential Information in confidence during and following termination or expiration of these Terms & Conditions. "SIL Confidential Information" includes but is not limited to all information, whether written or oral, in any form, including without limitation, information relating to the research, development, products, methods of manufacture, trade secrets, business plans, customers, vendors, finances, personnel data, Work Product (as defined herein), and other material or information considered proprietary by SIL relating to the current or anticipated business or affairs of SIL which is disclosed directly or indirectly to Seller. In addition, SIL Confidential Information means any third party's proprietary or confidential information disclosed to Seller in the course of providing Services or Goods to SIL. SIL Confidential Information does not include any information (i) which Seller lawfully knew without restriction on disclosure before SIL disclosed it to Seller, (ii) which is now or becomes publicly known through no wrongful act or failure to act of Seller, (iii) which Seller developed independently without use of the SIL Confidential Information, as evidenced by appropriate documentation, or (iv) which is hereafter lawfully furnished to Seller by a third party as a matter of right and without restriction on disclosure. In addition, Seller may disclose Confidential Information which is required to be disclosed pursuant to a requirement of a government agency or law so long as Seller provides prompt notice to SIL of such requirement prior to disclosure. Seller agrees not to copy, alter, or directly or indirectly disclose any SIL Confidential Information. Additionally, Seller agrees to limit its internal distribution of SIL Confidential Information to Seller's Assistants who have a need to know, and to take steps to ensure that the dissemination is so limited, including the execution by Seller's Assistants of nondisclosure Terms & Conditions with provisions substantially similar to those set forth herein. In no event will Seller use less than the degree of care and means that it uses to protect its own information of like kind, but in any event not less than reasonable care to prevent the unauthorized use of SIL Confidential Information. Seller further agrees not to use the SIL Confidential Information except in the course of performing hereunder and will not use such SIL Confidential Information for its own benefit or for the benefit of any third party. The mingling of the SIL Confidential Information with information of Seller shall not affect the confidential nature or ownership of the same as stated hereunder. Seller agrees not to design or manufacture any products which incorporate SIL Confidential Information. All SIL Confidential Information is and shall remain the property of SIL. Upon SIL written request or the termination of these Terms & Conditions, Seller shall return, transfer, or assign to SIL all SIL Confidential Information, including all Work Product, as defined herein, and all copies thereof.

12. OWNERSHIP OF WORK PRODUCT

For purposes of these Terms & Conditions, "Work Product" shall include, without limitation, all designs, discoveries, creations, works, devices, masks, models, work in progress, Service deliverables, inventions, products, computer programs, procedures, improvements, developments, drawings, notes, documents, information and materials made, conceived, or developed by Seller, alone or with others, which result from or relate to the Services performed hereunder. Standard Goods manufactured by Seller and sold to SIL without having been designed, customized, or modified for SIL do not constitute Work Product. All Work Product shall at all times be and remain the sole and exclusive property of SIL. Seller hereby agrees to irrevocably assign and transfer to SIL and does hereby assign and transfer to SIL all of its worldwide right, title, and interest in and to the Work Product including all associated intellectual property rights. SIL will have the sole right to determine the treatment of any Work Product, including the right to keep it as trade secret, execute and file patent applications on it, to use and disclose it without prior patent application, to file registrations for copyright or trademark in its own name, or to follow any other procedure that SIL deems appropriate. Seller agrees: (a) to disclose promptly in writing to SIL all Work Product in its possession; (b) to assist SIL in every reasonable way, at SIL expense, to secure, perfect, register, apply for, maintain, and defend for SIL benefit all copyrights, patent rights, mask work rights, trade secret rights, and all other proprietary rights or statutory protections in and to the Work Product in SIL name as it deems appropriate; and (c) to otherwise treat all Work Product as SIL Confidential Information as described above. These obligations to disclose, assist, execute, and

keep confidential survive the expiration or termination of these Terms & Conditions. All tools and equipment supplied by SIL to Seller shall remain the sole property of SIL. Seller will ensure that Seller's Assistants appropriately waive any and all claims and assign to SIL any and all rights or any interests in any Work

Product or original works created in connection with these Terms & Conditions. Seller irrevocably agrees not to assert against SIL or its direct or indirect customers, assignees, or licensees any claim of any intellectual property rights of Seller affecting the Work Product. SIL will not have rights to any works conceived or reduced to practice by Seller which were developed entirely on Seller's own time without using equipment, supplies, facilities, or trade secret or SIL Confidential Information, unless (i) such works relate to SIL business, or SIL actual or demonstrably anticipated research or development, or (ii) such works result from any Services performed by Seller for SIL.

13. NONINTERFERENCE WITH BUSINESS

During and for a period of two years immediately after the termination or expiration of this Terms & Conditions, Seller agrees not to unlawfully interfere with the business of SIL in any manner, and further agrees not to solicit or induce any employee or independent contractor to terminate or breach an employment, contractual, or other relationship with SIL.

14. TERMINATION

SIL may terminate these Terms & Conditions upon written notice to Seller if Seller fails to perform or otherwise breaches these Terms & Conditions, files a petition in bankruptcy, becomes insolvent, or dissolves. In the event of such termination, SIL shall pay Seller for the portion of the Services satisfactorily performed and those conforming Goods delivered to SIL through the date of termination, less appropriate offsets, including any additional costs to be incurred by SIL in completing the Services.

SIL may terminate these Terms & Conditions for any other reason upon thirty (30) days' written notice to Seller. Seller shall cease to perform Services and/or provide Goods under this Terms & Conditions on the date of termination specified in such notice. In the event of such termination, SIL shall be liable to Seller only for those Services satisfactorily performed and those conforming Goods delivered to SIL through the date of termination, less appropriate offsets. Seller may terminate this Terms & Conditions upon written notice to SIL if SIL fails to pay Seller within sixty (60) days after Seller notifies SIL in writing that payment is past due. Upon the expiration or termination of this Terms & Conditions for any reason: (a) each party will be released from all obligations to the other arising after the date of expiration or termination, except for those which by their terms survive such termination or expiration; and (b) Seller will promptly notify SIL of all SIL Confidential Information or any Work Product in Seller's possession and, at the expense of Seller and in accordance with SIL instructions, will promptly deliver to SIL all such SIL Confidential Information and/or Work Product.

15. REMEDIES

If Seller breaches these Terms & Conditions, SIL shall have all remedies available by law and at equity. For the purchase of Goods, Seller's sole remedy in the event of breach of this Terms & Conditions by SIL shall be the right to recover damages in the amount equal to the difference between market price at the time of breach and the purchase price specified in the Terms & Conditions. No alternate method of measuring damages shall apply to this transaction. Seller shall have no right to resell Goods for SIL account in the event of wrongful rejection, revocation of acceptance, failure to make payment or repudiation by SIL and any resale so made shall be for the account of Seller.

16. FORCE MAJEURE

SIL shall not be liable for any failure to perform including failure to (i) accept performance of Services or, (ii) take delivery of the Goods as provided caused by circumstances beyond its control which make such performance commercially impractical including, but not limited to, acts of God, fire, flood, acts of war, government action, accident, labor difficulties or shortage, inability to obtain materials, equipment, or transportation. In the event SIL is so excused, either party may terminate the Terms & Conditions and SIL shall at its expense and risk, return any Goods received to the place of shipment.

17. ATTORNEYS' FEES

In any action to enforce these Terms & Conditions, the prevailing party shall be entitled to recover all court costs and expenses and reasonable attorneys' fees, in addition to any other relief to which it may be entitled.

18. SEVERABILITY

If any provision of these Terms & Conditions shall be deemed to be invalid, illegal or unenforceable, the validity, legality, and enforceability of the remaining provisions shall not in any way be affected or impaired thereby.

19. LIMITATION OF LIABILITY

In no event shall SIL be held liable to Seller or Seller's Assistants, or any third party for any incidental, indirect, special or consequential damages arising out of, or in connection with, these Terms and Conditions, whether or not SIL was advised of the possibility of such damage, and whether or not there is any failure of any agreed upon remedy.

20. ASSIGNMENT; WAIVER

Seller may not assign these Terms & Conditions or any of its rights or obligations under this Terms & Conditions, without the prior written consent of SIL. Any assignment or transfer without such written consent shall be null and void. A waiver of any default hereunder or of any term or condition of these Terms & Conditions shall not be deemed to be a continuing waiver or a waiver of any other default or any other term or condition.

21. NONEXCLUSIVE TERMS & CONDITIONS

These are not exclusive Terms & Conditions. SIL is free to engage others to perform Services or provide Goods the same as or similar to Seller's. Seller is free to, and is encouraged to, advertise, offer, and provide Seller's Services and/or Goods to others; provided however, that Seller does not breach these Terms & Conditions.

22. NOTICES

Except for Purchase Orders which may be sent by local mail, or electronically transmitted, all notices, and other communications hereunder shall be in writing, and shall be addressed to Seller or to an authorized SIL representative, and shall be considered given when (a) delivered personally, (b) sent by confirmed email or facsimile, (c) sent by commercial overnight courier with written verification receipt, or (d) three (3) days after having been sent, postage prepaid, by first class or certified mail.

23. SURVIVAL OF OBLIGATIONS

Any obligations and duties which by their nature extend beyond the expiration or termination of these Terms & Conditions shall survive the expiration or termination of these Terms & Conditions.

24. GOVERNING LAW

These Terms & Conditions shall be construed in accordance with, and disputes shall be governed by, the laws of the **State of California** excluding its conflict of law rules. Jurisdiction and venue over all controversies arising out of, or relating to, this Terms & Conditions shall be in the **County of Santa Barbara**. The applicability of the UN Convention on Contracts for the International Sale of Goods is hereby expressly waived by the parties and it shall not apply to the terms and conditions of these Terms & Conditions.

25. ENTIRE TERMS & CONDITIONS; MODIFICATION

These Terms & Conditions are the complete, final, and exclusive statement of the terms of the Terms & Conditions between the parties and supersedes any and all other prior and contemporaneous negotiations and Terms & Conditions, whether oral or written, between them relating to the subject matter hereof. These Terms & Conditions may not be varied, modified, altered, or amended except in writing, including a purchase order or a change order issued by SIL, signed by the parties. The terms and conditions of these Terms & Conditions shall prevail notwithstanding any variance with the terms and conditions of any acknowledgment or other document submitted by Seller. Notwithstanding the foregoing, these Terms & Conditions will not supersede or take the place of any written Terms & Conditions which is signed by both parties and covers the same subject matter as these Terms & Conditions or its related purchase orders.

26. COMPLIANCE WITH LAWS

26.1. General

Seller shall comply fully with all applicable federal, state, and local laws in the performance of these Terms & Conditions including, but not limited to, all applicable employment, tax, export control, and environmental laws.

26.2. Hazardous Materials

If Goods include hazardous materials, Seller represents and warrants that Seller understands the nature of any hazards associated with the manufacture, handling, and transportation of such hazardous materials.

26.3. Customs

Upon SIL request, Seller will promptly provide SIL with a statement of origin for all Goods and United States Customs documentation for Goods wholly or partially manufactured outside of the United States.

27. INJUNCTIVE RELIEF

Seller acknowledges and agrees that the obligations and promises of Seller under these Terms & Conditions are of a unique, intellectual nature giving them particular value. Seller's breach of any of the promises contained in these Terms & Conditions will result in irreparable and continuing damage to SIL for which there will be no adequate remedy at law and, in the event of such breach, SIL will be entitled to seek injunctive relief, or a decree of specific performance.

28. SIL's Customer's Requirements & SIL's Customer's Terms & Conditions

Should any of the above SIL LLC. Terms & Conditions have conflict with Customer's requirements; the customer's requirements may supersede SIL terms & Conditions.
